

Fall 2008: Exams are held for two weeks at the end of the semester. The fall period begins Monday, December 8 and ends Friday, December 19. Scheduled exams are given at specifically assigned times, usually only once during the exam period. Unscheduled exams may be picked up at the Registrar's office between 8:30-9:00am, 1:00-1:30pm; 6:00-6:30pm on unscheduled exam days.
