LITIGATION AND ENVIRONMENTAL ADVOCACY EXPERIENCE

Sierra Club, et al. v. Portland General Electric Co. (U.S. District of Oregon 2011). Lawsuit in federal district court against coal-fired power plant for violations of Clean Air Act and state implementation plan. Achieved favorable ruling holding, *inter alia*, that the provision in Clean Air Act requiring a petition for review of final agency action to be filed within 60 days after agency action does not apply retroactively to Environmental Protection Agency's determination that electric company commenced construction on electricity generating station prior to July 1, 1975, and thus, the district court did not lack jurisdiction to review whether company commenced construction of the station without having obtained requisite permits. Clean Air Act, §§ 304, 307(b)(1), 42 U.S.C.A. §§ 7604, 7607(b)(1). Case settled October 2011.

In the matter of ESCO Corp (2011). Negotiations with a foundry - ESCO Corporation – on behalf of neighborhood and environmental groups wherein ESCO agreed to reduce its air pollution by 20% - 40% over the next five years.

Oregon Regional Haze Rule (Oregon EQC 2010). Represented five local, regional and national conservation organizations in administrative rulemaking to reduce pollution from Oregon's largest source of air pollution. Conclusion of matter resulted in an enforceable requirement for Oregon's only coal-fired power plant to transition from coal at least 20 years early.

In re: Shell Offshore, Inc. Kulluk Drilling Unit and Frontier Drilling Unit (EAB 2007). Represented the North Slope Borough in Petition for Review to the Environmental Appeals Board challenging the issuance of a Prevention of Significant Deterioration permit to Shell Offshore, Inc. for exploration drilling on the Outer Continental Shelf. The EAB upheld the permit in part and remanded the permit in part.

In the matter of Energy Northwest Pacific Mountain Energy Center Power Project (Washington EFSEC 2007). Represented conservation organizations in a challenge to a new coal-fired power plant on the Columbia River based on the applicant's failure to satisfy Washington's Climate Change Law. On November 27, 2007, less than three weeks after briefing was completed, the Washington Energy Facility Site Evaluation Council (EFSEC) concluded that Energy Northwest failed to satisfy the law's requirements and could not build the plant.

Kosta Scrap Metal Stormwater Enforcement (2007). Represented conservation organization in a stormwater enforcement case challenging the illegal and unpermitted discharge of contaminated stormwater from a scrap metal facility in North Portland. Favorable settlement achieved.
