THIS IS A SUMMARY OF THE ANNUAL REPORT FOR THE LEWIS AND CLARK COLLEGE DEFINED CONTRIBUTION RETIREMENT PLAN AND TAX DEFERRED ANNUITY PLAN, (EMPLOYER IDENTIFICATION NO. 93-0386858, PLAN NO. 001) FOR THE PERIOD JANUARY 1, 2013 TO DECEMBER 31, 2013. THE ANNUAL REPORT HAS BEEN FILED WITH THE EMPLOYEE BENEFITS SECURITY ADMINISTRATION, AS REQUIRED UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974 (ERISA).

BASIC FINANCIAL STATEMENT

BENEFITS UNDER THE PLAN ARE PROVIDED BY A TRUST (BENEFITS ARE PROVIDED IN WHOLE FROM TRUST FUNDS). PLAN EXPENSES WERE \$9239445. THESE EXPENSES INCLUDED \$3117 IN ADMINISTRATIVE EXPENSES AND \$9236328 IN BENEFITS PAID TO PARTICIPANTS AND BENEFICIARIES. A TOTAL OF 1675 PERSONS WERE PARTICIPANTS IN OR BENEFICIARIES OF THE PLAN AT THE END OF THE PLAN YEAR, ALTHOUGH NOT ALL OF THESE PERSONS HAD YET EARNED THE RIGHT TO RECEIVE BENEFITS.

THE VALUE OF PLAN ASSETS, AFTER SUBTRACTING LIABILITIES OF THE PLAN, WAS \$182153894 AS OF DECEMBER 31, 2013 COMPARED TO \$158430315 AS OF JANUARY 1, 2013. DURING THE PLAN YEAR THE PLAN EXPERIENCED AN INCREASE IN ITS NET ASSETS OF \$23723579. THIS INCREASE INCLUDES UNREALIZED APPRECIATION OR DEPRECIATION IN THE VALUE OF PLAN ASSETS; THAT IS, THE DIFFERENCE BETWEEN THE VALUE OF THE PLAN'S ASSETS AT THE END OF THE YEAR AND THE VALUE OF THE ASSETS AT THE BEGINNING OF THE YEAR, OR THE COST OF ASSETS ACQUIRED DURING THE YEAR. THE PLAN HAD TOTAL INCOME OF \$32963024, INCLUDING EMPLOYER CONTRIBUTIONS OF \$3977423, EMPLOYEE CONTRIBUTIONS OF \$3183660, OTHERS CONTRIBUTIONS OF \$1121755 AND EARNINGS FROM INVESTMENTS OF \$24680186.

THE PLAN HAS CONTRACTS WITH TIAA-CREF, AND RELIASTAR LIFE INSURANCE COMPANY WHICH ALLOCATE FUNDS TOWARD INDIVIDUAL POLICIES.

MINIMUM FUNDING STANDARDS

ENOUGH MONEY WAS CONTRIBUTED TO THE PLAN TO KEEP IT FUNDED IN ACCORDANCE WITH THE MINIMUM FUNDING STANDARDS OF ERISA.
