Chris is thankful of the timing of the Spring BoA Meeting this year as it coincides with the great student event the 58th International Fair, organized by International Students of Lewis & Clark!

Chris Ohman '77 –President's Report

■ The Randall Trust awards **\$1.5 million gift** to fund an endowed professorship at the John E. and Susan S. Bates Center for Entrepreneurship and Leadership.

■ **Community Dialogues:** January 2023 marked the launch of Community Dialogues, President Holmes-Sullivan's signature initiative. This ongoing program is intended to make healthy, constructive dialogue a part of our identity as an institution, and the foundation of how we relate to

each other in community in both informal and formal settings. In April, students will be invited to participate in a Community Dialogue on the topic of the L&C Pioneer Mascot.

■ **Posse Scholars:** In an expansion of its three-year relationship with the Posse Foundation, Lewis & Clark will welcome to campus this fall its inaugural cohort of scholars from Posse's newest recruitment location: Puerto Rico. These students will join L&C's third group of Posse scholars from Washington, D.C., making L&C Posse's only dual-program institution in the Pacific Northwest.

■ **Construction progress:** We are actively addressing the list of deferred maintenance, which is a good sign of the college's financial health. The Fowler Student Center renovations are shaping up with an overhaul of the Trail Room, the relocation of the student organizations to a more visible location, the creation of more flexible events spaces, significantly improved accessibility, and a new elevator from the lower parking lot up to the Stamm dining room level. Stewart Odell renovations are in progress as are the Huston Sports Complex improvements.

■ **Comprehensive Campaign:** We are closing in on the final goal of \$155 million raised. More on this when Julie and Edgard give their fundraising and philanthropy updates.

■ **New VP of Communications:** Lori Friedman will start her new role on March 13. She has nearly two decades of experience as a strategic communications and media relations specialist. Friedman was most recently at Lehigh University in Pennsylvania, where she and her team are credited with dramatically increasing the institution's visibility and reputation as a national and international higher education leader.

■ **Enrollment:** CAS applications are down slightly from a record high last year and the plan is to have a class that is at or slightly lower than last fall. **Grad School** enrollment is down slightly but not in a way that is concerning. Applications are still strong, particularly the counseling programs. The master's in education is having some challenges and has been impacted by a lowering of school funding. **Law school** applications are down 20% but the quality of LSAT scores and GPA is up and is part of an eight-year upward trend.

#### ■ **Trustees March Retreat**

The Board of Trustees met at a strategic retreat and Chris shares with the Board members some of the themes that came out of that retreat, including three articles that would be a good read to understand the framing of the retreat. The three articles are about trends in college age students and the implications for the colleges and universities that serve them. They were distributed to the Board of Trustees as a pre-read prior to the March retreat and strategy discussion.

Digital links to the articles will be shared with members in the next week or so.

**Stacy** – It is important that this Board also have a thoughtful strategic planning session. We as a board have an opportunity to add our voices to this strategic conversation and can shape the direction of the college at this time.

Administration Committee Update – Peter Dempsey '01

The committee is entering the busy season with the new member elections coming up at the next June virtual meeting.

Proposed changes to the bylaws were shared with the Board on February 17, 2023.

Peter did receive some comments from Board members but in general, there were no concerns about the proposed changes to the bylaws. The comments were mostly about minor grammatical changes.

David mentions that it is a common practice to have a provision in a board's bylaws document to allow for minor grammatical changes without requiring a full vote from the board. This provision is typically referred to as a "housekeeping" provision. The purpose of the housekeeping provision is to allow the board to make minor changes to the bylaws document, such as correcting spelling errors or adjusting punctuation, and department name changes without having to go through the formal process of a full vote. This helps to ensure that the bylaws document remains accurate and up-to-date. The provision should outline the types of changes that are considered minor and therefore eligible for the housekeeping process, as well as the procedures for making those changes. The provision should be structured in a way that balances the need for flexibility with the need for transparency and accountability.

It is decided to add a “housekeeping” provision to the bylaws to share with the board prior to the June meeting and vote for approval at that time if time permits.

■ E&I Charter document - draft

After a year of thoughtful work, the committee presents for consideration to the board an E&I Committee Charter. The purpose of the charter is to create a structure for the committee's work, mission, goals, objectives and purpose. The charter will better solidify what the committee is trying to achieve and act as a blueprint to help and guide future committee members. This document is still in draft format and will be shared with Danielle Torres, *Dean of Equity and Inclusion* for final input. The Charter would be updated as needed to stay in alignment with the college's overall strategic plans as they evolve.

■ Lewis & Clark Native Alumni Association (LCNAA)

The LCNAA is almost officially finalized. The LCNAA seeks to create a supportive environment for current and former students and to serve as a resource to the Native Student Union (NSU), Native American Law Student Association (NALSA) and other Native students on campus.

■ Lewis & Clark Black Alumni Association (LCBAA)

**LCBAA recent events:**

- October 21, LCBAA Dessert Reception was held on the day of the inauguration of **Dr. Robin Holmes-Sullivan** as the 26th president of Lewis & Clark College, with about twenty alumni attending.
- March 3, the LCBAA had a meet and greet at Portland's martini bar Olive or Twist, eleven alumni attended.
- March 4, the LCBAA also had a brunch meet up with current black students that was well attended

**LCBAA upcoming Event:**

- June 24, Saturday of Alumni Weekend: **Juneteenth Commemoration.**  
A commemoration of the United States' newest national holiday including a libation and meaningful readings.

■ **BSU Mentoring Program:**

In the spring of 2023, the E&I Committee collaborated with the Black Student Union (BSU) to launch a mentorship program. The program is for current students to connect with Alumni and build a mentorship relationship, as a way to receive support, guidance and strategies for post-graduation opportunities.

■ **Alumni Survey**

With the cooperation of the institutional research team, we were able to get some E&I related questions onto the Alumni survey that went out last fall. Hopefully by the June meeting we will be able to report on some of the data in regards to engagement.

Athletics Liaison Update – Jenifer Kerns '90

- 25% of the incoming freshman class this fall were recruited athletes. This is a record number of 167 freshman athletes. This year has 425 student athletes, and is the largest number Mark Pietrok has seen in his 34 years with the college.
- Increased successes with teams – football had a .5 winning season. Women’s soccer finished fourth in their division. Cross Country was second and third (Men & Women) in the conference.
- Excited about the college adding sports: men’s soccer and women’s lacrosse. First time in decades adding a women’s sport.
- Theme for the year: celebration of 50 years of Title IX. Number of events to highlight – culminating at the end of the year awards ceremony. In February, the Hestor Turner Endowment was announced and is currently raising funds. Started in 2022 in conjunction with the 50<sup>th</sup> anniversary of Title IX and named for a longtime L&C faculty and staff member, this on-going fund is the first endowment named after a woman in Lewis & Clark Athletics history. The endowment will support women's athletic programs and create additional opportunities to boost the student-athlete experience for students competing on women's teams on campus.
- 5 million project to transform the Houston Sports Complex into a multi-purpose facility, strengthening our baseball and softball programs and expanding our varsity sports support for men’s soccer and women’s lacrosse.
- Griswold stadium rafters are undergoing a redoing of the roof and press box.
- In Pamplin the women’s locker room facility and the athletic training facility have both been expanded.
- Another fund to support the men’s soccer program in the name of Grant Frey ’83 P’ 11 P’ (former Board of Alumni member) is really close to being endowed.
- Lewis & Clark inducted in October an all-female Hall of Fame class of 2022.

#### Admission Liaison Update – Erik Jensen ’81

- \$146.5 million dollars in total gifts (commitments and gifts)
- 94.5% toward goal (commitments and gifts)
- \$8.5 Million left to raise (commitments and gifts)

We are trying to conclude the campaign one year early sometime this summer/fall.

Most of the numbers in the handout are not up to date because they do not include this year's Day of Giving on March 1<sup>st</sup>. Day of Giving is one of our biggest fundraising days of the year.

■ **Day of Giving, March 1, 2023**

CAS goal was 1,000 donors and we reached 1,184 donors, which unlocked \$200,000 in matches throughout the day. Total raised \$381,838.

Current: 15/23 members (65%) as of 2/22/23

■ **April: CAS Renewal Campaign – Fir Acres Society** (donors giving to CAS for 3+ consecutive years)

■ **April:** Class of 1973/2023 Together Scholarship Launch event on April 13.

1973 alumni and 2023 parents are funding the majority of the Scholarship while seniors get a voice in shaping it.

■ **May:** Fiscal Year End (FYE) Push!

Last Chance for alumni to give and count in LC's ranking.

■ **Alternative Break Program**

The Center for Social Change and Community Involvement is bringing a group of students on an Alternative break program going to Puerto Rico where they will be doing service projects, learning about community, and connecting with the new Posse cohort. Students are involved in fundraising to cover the costs and the Goal is to raise \$12,000 by March 17.

All giving collected from 6/1/22 – 6/30/23 from reunion classes ending in 3 or 8 will go toward the class gift total
