## Application to Audit

Your name will appear on the class roster, and you will receive a final grade of "Audit." The fee to audit is \$150 per credit hour, plus any additional course fees. To register to audit a course, you must obtain the instructor's permission in writing. Auditors are welcome to take classes during the summer term only. Applications to audit will be accepted after May 1.
