Standards of Conduct for Club Sports Events

The Standards of Conduct shall serve as a guideline for how individuals are expected to behave when participating in Lewis & Clark College Club Sports sponsored or endorsed activities. Students enrolled in an institution of higher learning assume an obligation to conduct themselves in a manner compatible with the college's function as an educational institution. When club sports members participate in an event sponsored or endorsed by Lewis & Clark College, the member indicates, by their participation in the event, they agree to represent their club and Lewis & Clark College in a way that does not detract from the reputation of the institution they are representing, and to act morally and display sportsmanship-like behavior, before, during and after any competition. Guidelines of conduct include, but are not limited to the examples outlines below.

Participants Shall Not:

- Use drugs, except for medical purposed, while traveling, competing, socializing and/or using facilities including college spaces.
- Consume alcohol while traveling (from the time the team leaves campus to the time it returns), competing or spectating.
- Strike, attempt to strike or otherwise physically abuse an official, opposing player, spectator or coach.
- Violate and host rules or policies.

Violations of the Standards of Conduct may result in:

- Forfeiture of all Traveling Funds for one full year.
- The removal of offending team members.
- Participation in a team building workshop.

Team Responsibilities will include:

- Educate club members of the Standards of Conduct and consequences of misconduct.
- Ensure that all team members adhere to the Standard of Conduct.

ADDITIONALLY, I understand and acknowledge that by my participation on a Lewis & Clark College club sport team I am subject to the provisions of the student Code of Conduct, irrespective of on-campus or off-campus location whether the club sport activity be educational, recreational, athletic or social.
