New, and dangerous, theories of lawyer liability will continue to develop for as long as there are creative lawyers to develop them. One such theory, which is gaining ground in Oregon and other states, concerns lawyer liability to non-client third parties for helping their clients breach fiduciary duties owed by the clients to the third parties. This session will examine the current and evolving state of the law in this troubling area and discuss the elements of such a claim and how to avoid them.
