- 5. The scholarship will be delivered to the winner by October 15, after confirmation that the student is still enrolled in an Oregon law school.

Applicant must submit the following items:

- 1. Completed application form (if handwritten, please print legibly)
- 2. Personal statement limited to 250 words containing a brief explanation about yourself, your classes and work related to Intellectual Property Law, including extracurricular activities, and your career goals.
- 3. An official and recent transcript from your law school with cumulative grade point average and a class standing/rank.
- 4. No recommendation letters are required.

**Deadline** for the application is **June 15, 2014, 5:00 p.m.** Applications postmarked after this date will not be considered.
