- Lewis & Clark College signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.
- 2. Lewis & Clark College will receive or has received \$4,177,663 from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.
- 3. As of March 31, 2021, a total of \$0 in Emergency Financial Aid Grants had been distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.
- 4. There were approximately 4,349 number of students at Lewis & Clark College eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs. This is based on enrollment in Spring 2020, Summer 2020, Fall 2020, and Spring 2021.
- 5. As of March 31, 2021, no students had received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.
- 6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs: Students with the highest financial need at all three schools (CAS, GSEC, Law) were identified based on factors including Pell eligibility and/or low EFC. These students were prioritized into two groups based on EFC and other need factors. Students with the highest demonstrated need, priority group one, were invited to accept a set award amount. Priority group two students were invited to accept a set award amount lower than those students identified in priority group one. No distributions were made prior to March 31, 2021.
- 7. Instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants: Beginning in late March 2021, and continuing through June 2021, prioritized students were invited via email to accept their CRRSAA funding awards by a specified deadline, and received reminders. Students were given the option to accept or decline their award via a Google Form. In addition, the College has maintained a <u>public website</u> that includes updates about emergency funding available to students and the methods of distribution.
